# **DR. GUS A. STAVROS**

Pinellas Education Foundation Founding Chair

Dr. Gus A. Stavros has forever changed the lives of countless students in Pinellas County and beyond with his generosity and dedication. His leadership forged the Pinellas Education Foundation into the thriving, nationally acclaimed organization it is today, and his passion for education continues to be the driving force behind each and every one of our initiatives.

For more than 35 years, Dr. Stavros was engaged with the Pinellas Education Foundation, serving as founding chair of the Board of Directors. He also raised \$1.1 million through local business donations and his own money to start Enterprise Village in 1989, and he served on the State University System Board of Governors, which is one of the most prestigious state government appointments. He and his wife, Frances, were also patrons of various arts organizations, Lutheran ministries, and charitable organizations. They were known for their generosity, and Dr. Stavros once said his aim was to give away most of his money eventually and die poor.

Born in New Jersey to Greek immigrant parents, Dr. Stavros earned a Bronze Star and a Purple Heart serving on the European front during World War II. After attending Columbia University and getting married in 1948, he and Frances eventually moved to Pinellas County a decade later. Frances passed away in 2017 at the age of 92.

Dr. Stavros was 97 when he passed away on October 18th this year. He left an indelible mark on the world through his extraordinary efforts, and his vision lives on and will continue to impact young lives in Pinellas County Schools, the entire Tampa Bay community and around the world. We are honored to carry on his legacy.
