Academic Achievement

We support teachers and principals by offering opportunities to improve instruction methods and increase student outcomes. We do this through programs such as Closing the Gap, Pinellas Early Literacy Initiative and Reading Recovery.

Success in Action

Closing the Gap

We have been committed to closing gender-based achievement gaps for over 10 years. Research has shown that boys and girls learn differently. Boys often exhibit more physical energy with the need to move, enjoy competition and prefer shoulder-to-shoulder interaction over face-to-face. Recent research published by Helios Education Foundation details that gender gaps still exist, with boys significantly lagging behind girls in English Language Arts (ELA) throughout elementary and middle school in Florida.

Together with Pinellas County Schools, we focus on research-driven instructional strategies to increase student success. We know that changing instruction and learning environments is critical to closing gender achievement gaps and eliminating gender disparities. Our Closing the Gap program started with just 6 elementary schools, and has now expanded to 22 schools, providing grant funding for teachers to learn gender-based instruction methods and purchase materials to eliminate gender gaps.

We are proud to report that in 2022-2023, Closing the Gap directly impacted over 4,000 students with nearly 300 teachers receiving gender-specific instruction methods. This initiative is a key example of how we bring together business and community leaders to partner with Pinellas County Schools to impact student outcomes and set teachers up for success.

Boys Read Book Battle

Another strategy that resulted from this vital work was creating an annual Boys Read Book Battle, a program aimed at getting boys engaged in reading and reading retention. The book battle occurs over a series of events culminating in one grand finale competition. During the finale event, the teams of elementary school boys are challenged to put their reading, comprehension and evidence-finding skills to the test and answer questions about books they were assigned during the school year. Last year, 41 elementary schools participated in the Boys Read Book Battle and Ponce de Leon Elementary School took the trophy home!

Multiple Pathways

We believe all students should have the necessary tools for academic success and plans to succeed during and after high school. Whether going to college, skillfully entering the workforce, or obtaining career technical training. Our programs that prepare students for life after graduation include Career & Technical Education, Elevating Excellence: College & Career Centers, Senior Scholarships, Student Internships, Take Stock in Children, Teacher Externships and Walker's Rising Stars.

Success in Action

30th Anniversary of Take Stock in Children

Over 30 years ago, we saw a need to address low graduation rates for economically disadvantaged students in Pinellas County by offering them one-on-one mentoring and the promise of a college scholarship upon graduation.

The initial Take Stock in Children program started with only 20 students. The program was so successful at raising graduation rates that it grew into a statewide initiative in 1996. The program was also known by the

name Doorways for many years in Pinellas County.

Every year, we serve approximately 1,000 students with over 600 caring mentors who dedicate their time to help guide these students, who may have thought college or technical training was not possible for them.

In 2022-2023, over \$2.8 million in scholarships were awarded to graduating seniors and college students pursuing a

post-secondary education. Over 2,500 students have earned their post-secondary degrees. We are the state's largest Take Stock in Children provider and take great pride in providing students with the tools they need to succeed in life after high school.

Success in Action

Finish Line Scholarships

In recent years, Florida expanded the opportunity for students to earn dual enrollment credit at public school career and technical colleges. In Pinellas County, this allows students to dual enroll at Pinellas Technical College and take college-level courses for credit at no cost to them.

A difference between traditional college dual enrollment and career and technical education (CTE) dual enrollment is the time it takes to earn a certification. 60% of CTE dual enrollment programs take 1,050 hours (one year) to complete when attending full-time. High school students can enroll in limited classes per semester because they are still working on mandatory classes for graduation requirements. This results in some students being unable to complete the hours necessary to earn their certification by graduation. Students with less than 600 hours remaining are no longer eligible for federal aid, such as Pell Grants, because financial assistance is only available to students with more than 600 hours remaining. Students who can pay continue in the program, but students who need financial aid often drop out of their programs because they need more funding.

We created the Finish Line Scholarship to help students who need financial assistance but are ineligible to cross the finish line and complete their CTE certifications. In the 2022-2023 school year, we awarded over \$33,000 in Finish Line Scholarships to students in automotive, computer sciences, electrical, and medical programs.

Enhancement Programs and Other District Support

Success in Action

Our enhancement programs cultivate a supportive culture for teachers and offer students the chance to develop essential skills. They include Enterprise Village, Finance Park, Evening of Excellence, Focus on Education, Fund a Classroom, Digital Equity, Next Generation Entrepreneur, Tampa Bay School Supply Drive and TB12 Fitness Program.



With a shared commitment to innovation and student achievement, in collaboration with Pinellas County Schools, we partnered with the TB12 Foundation to launch a new physical education curriculum. The TB12 Foundation is a non-profit organization founded by retired NFL superstar, Tom Brady. The core focus of this addition was to enhance middle and high school students' health and wellness competencies.

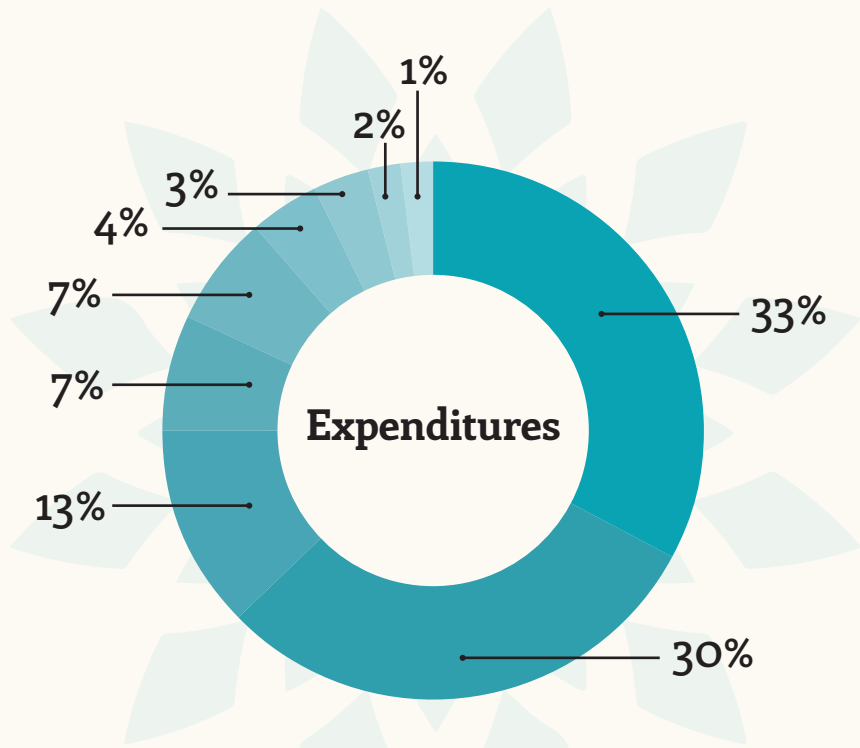
The new curriculum rolled out in the fall of 2022 at 6 middle and 4 high schools. Certified TB12 Body Coaches worked with district physical education instructors, athletic coaches and administrators to help develop coursework. The program expanded to all middle and high school physical education courses in the fall of 2023.

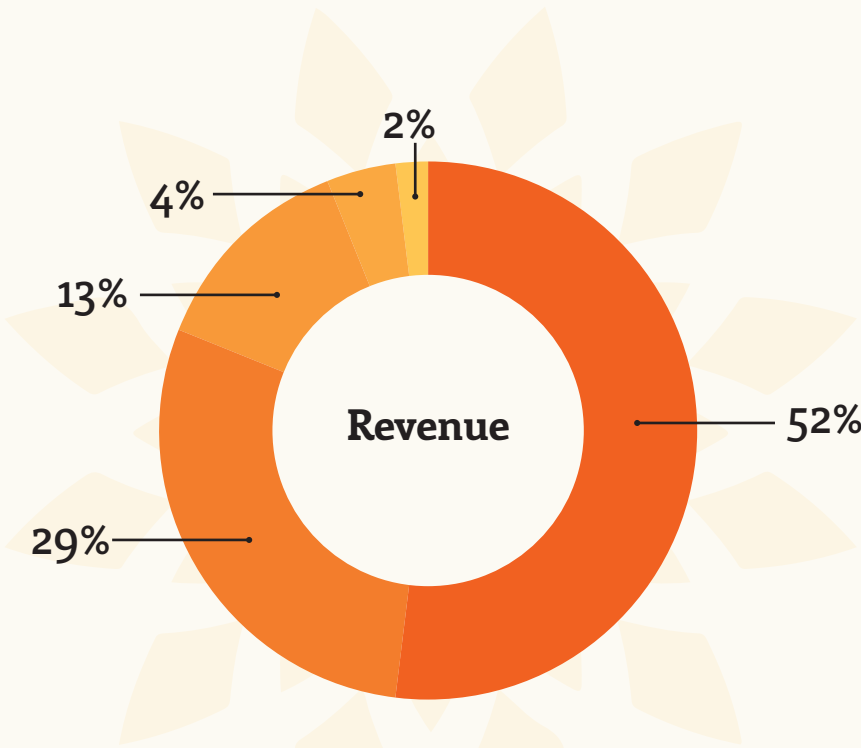
