(Revenue \$) OUR TAKE STOCK IN CHILDREN (TSIC) PROGRAM IS A LONG-TERM INITIATIVE THAT PAIRS LOW-INCOME STUDENTS WITH CARING MENTORS, COLLEGE SUCCESS COACHES AND GIVES THEM A COMMITMENT OF A COLLEGE SCHOLARSHIP. STUDENTS ENTER THE PROGRAM BETWEEN THE GRADES OF 6-9 AND WE CONTINUE TO SUPPORT THEM THROUGH THEIR HIGH SCHOOL GRADUATION. STUDENTS MUST MAINTAIN AT LEAST A 'C' AVERAGE IN ALL CLASSES, MEET REGULARLY WITH THEIR MENTOR, REMAIN DRUG AND CRIME-FREE, ATTEND COLLEGE SUCCESS PLANNING MEETINGS, AND GRADUATE FROM HIGH SCHOOL. WE PROVIDE RESOURCES AND SUPPORT FROM THE TIME STUDENTS ENTER THE PROGRAM THROUGH THEIR POSTSECONDARY ATTAINMENT, SERVING APPROXIMATELY 1,100 STUDENTS ANNUALLY. STUDENTS MUST BE ENROLLED AS SENIORS IN PINELLAS COUNTY SCHOOLS, AND THESE SCHOLARSHIPS ARE SEPARATE FROM OUR TAKE STOCK IN CHILDREN MENTORING PROGRAM SCHOLARSHIPS.
